### **ABOUT**

Strafford County Public Health Network (SCPHN) is one of New Hampshire's 13 Regional Public Health Networks (RPHNs) established in July of 2013. RPHNs were created to integrate multiple public health initiatives and services into a common network of community stakeholders, and coordinate the development implementation of a range of community and public health improvement activities. Greater Seacoast Community Health is the host agency for SCPHN, which includes the following municipalities: Barrington, Dover, Durham, Lee, Madbury, Middleton, Milton, Rochester. Durham, Rollinsford. Somersworth, and Strafford, as well as the University of New Hampshire.

### **SCPHN WORKGROUPS**

## Addiction Task Force (ATF)

The Strafford County ATF is a group of stakeholders from across Strafford County that work toward shared goals related to the prevention, treatment, recovery, and reduction of harm from substance use and mental health. ATF meets on the 3rd Tuesday of each month.

# Prevention Leadership Group (PLG)

The Strafford County PLG is a coalition of partners working collectively on projects to prevent substance use and mental health challenges across Strafford County. PLG meets on the 1st Tuesday of each month.

# **Healthy Living Coalition (HLC)**

The Strafford County HLC is a group of stakeholders working to improve food security and nutrition, and to decrease the impact of chronic disease such as obesity, heart disease and stroke. The Healthy Living Coalition meets on the 3rd Thursday of each month.

# **ACCOMPLISHMENTS**

### **YOUNG ADULT STRATEGIES**

At the end of State Fiscal Year 2022, the NH Dept. of Health and Human Services (DHHS) restructured their funding to and support substance use suicide prevention in the young adult population (ages 18-25). SCPHN was awarded the \$500,000 contract to coordinate the statewide efforts of this grant over the next two years. SCPHN has subcontracted with three RPHN's who are located strategically throughout the state and have a history of successfully working with this population; Manchester 'Makin' it Happen', North Consortium. Country Health Dartmouth Hitchcock, which oversees both the Upper Valley and Greater Sullivan regions.

### **ADVOCACY**

SCPHN was awarded \$5,000 from the NH Charitable Foundation in partnership with New Futures to support SCPHN's advocacy work by providing community educational opportunities and hosting a Legislative Breakfast. Our breakfast, held on Friday, April 28th at the Career Technical Center at Spaulding High School, highlighted how different barriers are affecting access to care and impacting residents of Strafford Topics discussed included County. Medicaid Expansion, workforce shortages, housing and cost of living, reimbursement rates, the importance of supporting the Alcohol Fund, and more. We also shared information about how these issues relate to and are impacted by current bills and policies in NH.



### **ADDICTION SUMMIT**

Our 2023 Addiction Summit, hosted by our Addiction Task Force, welcomed 120 people on Wednesday, May 24th at UNH. We had ten workshops that crossed the continuum of care and related topics, a keynote address on Cultural Change in Substance Use Disorder Treatment: An Organizational Approach from Wentworth-Douglass Hospital, and a Overcoming Community panel on Barriers to Recovery, which included perspectives on topics related to social determinants of health. We received one Champion-level sponsorship Kennebunk Savings Bank at \$1,500 and one Supporter-level sponsorship from Unite Us New Hampshire at \$500.



#### SYRINGE DISPOSAL

SCPHN was awarded \$5,100 through the Wentworth-Douglass Hospital Community Benefits Program to support a Public Syringe Disposal Pilot Project in the City of Dover, which was approved unanimously by the Dover City Council. This project installed two public syringe disposal units in public areas in the City of Dover that have regular concerns regarding improperly disposed This collaborative syringes. includes partners from the NH Harm Reduction Coalition (NHHRC), UNH Harm Reduction, Education & Technical Assistance (HRETA) project, SOS Recovery Community Organization, the Doorway at WDH and the City of Dover.



# **ACCOMPLISHMENTS**

### **SCHOOL BASED & ADULT FLU CLINICS**

The 2022 flu clinic season included a mix of both in-school and drive-thru clinics at 29 participating schools in the region; 4 more than 2021. This year, we vaccinated 889 students, an additional 202 students, a 29% increase, from 2021. In addition to Greater Community Seacoast Health staffvolunteers, our use of NH Responds for the COVID vaccination efforts allowed us to outreach to our existing MRC volunteer base, as well as continuing our partnership with the UNH Nursing program to provide the staffing for these clinics.

# **COMMUNITY HEALTH WORKER (CHW)**

Our CHW ran several community-based COVID-19 and Flu vaccination clinics for vulnerable populations in our communities such as people experiencing homelessness and those accessing community resources like We Care Food Pantry in Milton.

Community Outreach is regularly done to build awareness of resources and supports across our CHIP priorities with partners such as local libraries, the Mobile Health Program, the Warming Center, and at events in our region and statewide, including Seacoast Eat Local Farmers Markets, Somersworth High School Wellness Night, UNH Age of Champions and more.



### **DATA COLLECTION**

SCPHN received \$13,000 from United Way of the Greater Seacoast to support the implementation of the Youth Risk Behavior Survey (YRBS) at Strafford County Middle Schools. The 2023 MS YRBS was administered in Rochester , Somersworth, Oyster River, and Dover schools. Unfortunately, Farmington, a regular participant, did not participate in the 2023 iteration.



# EMERGENCY PREPAREDNESS & MEDICAL RESERVE CORPS (MRC)

- Disseminated personal protective equipment (PPE) & test-kits to community & partner organizations
- Worked with GSCH's Mobile Health Program to provide low-barrier community-based vaccine clinics
- Worked collaboratively with Seacoast RPHN to ensure continuity of information and resource sharing
- 45 MRC volunteers were utilized to staff 21 vaccine clinics from Fall 2022
   Spring 2023
- Monthly trainings were offered to MRC volunteers in collaboration with Seacoast RPHN regarding topics like Diabetes/Heart Disease, Pregnancy and Emergency Preparedness, Self-Care/Meditation, Suicide Prevention, Fire Safety, Exposure and Risk Management, Shelter Fundamentals, Responder Resilience & more

## **ACCOMPLISHMENTS**



Since July, 2022 SCPHN has distributed over 300 kits of Narcan, more than 600 Fentanyl test strips, and approximately 450 overdose prevention kits to organizations, businesses and individuals throughout Strafford County.

#### SUICIDE PREVENTION

This past year our SMP and DMHA collaborated with American Foundation for Suicide Prevention to organize their second annual Out of Darkness Walk in May 2022, and their second annual Survivor of Suicide Loss Support group in November 2022. SCPHN also provided many suicide prevention and mental health education opportunities throughout the region.







#### **RESOURCE SHARING**

Our Substance Use & Mental Health Resource Guides have been completed, distributed to printed. and hundreds partners engaged with our Coalitions and working groups, as well as schools and other partner organizations across the region. These guides provide information about and services across continuum of care, including basic needs, as well as information about how to support this type of work in our communities. In addition to our Resource Guides, the Addiction Task Force developed Pocket Guides, which include key resources across the continuum, and link to our larger, more comprehensive Resource Guide, but are more easily kept available for use in times of need.



### **TAKEBACK DAY**

DEA Take Back Day events provide an opportunity twice per year in April and October, to safely dispose of unused prescription medication, helping to prevent prescription drug misuse, addiction and overdose deaths.

SCPHN assists the DEA by providing local law enforcement with Takeback Day supplies. In addition to providing DEA supplies, we provide additional resources such as Deterra bags, SAMHSA resources, local community resources and those developed by SCPHN.

We were able to attend the Strafford County Police Chief's Meeting in April 2023 to provide supplies and highlight prevention resources to local PDs.
