The pieces of legislation in this list relate to the topics discussed today. As you consider these bills, and others like them, we ask that you keep in mind the information and stories our panel and speakers shared.

## Housing

**SB538-L:** Relative to zoning procedures concerning residential housing.

**HB1101:** Establishing a committee to study a potential state program to make loans to low-to-moderate income households for the purpose of buying a home or for the purpose of consolidating student loans.

**HB1168:** Establishing a committee to study the impact of the housing crisis on people with disabilities.

**HB1199:** Relative to services of the office of the child advocate for youth experiencing homelessness and making an appropriation therefor.

**HB1291:** Relative to accessory dwelling unit uses allowed by right.

**HB1362:** Relative to authorizing municipalities to stabilize rent increases in rental housing.

**HB1399:** Allowing municipalities to permit 2 residential units in certain single-family residential zones.

**HB1470:** Establishing a study committee on the feasibility and impact of a low-income housing tax credit.

**HB1545:** Relative to the disposal of state surplus property for affordable housing.

**HB1672:** Relative to tenants in section 8 public housing.

**SB224:** Relative to housing opportunity zones and inclusionary zoning.

**SB384:** Relative to a municipal loan and grant program for rental housing and making an appropriation therefor.

**SB406:** Relative to emergency housing assistance and making an appropriation therefor.

**SB408:** Establishing a committee to study the effects of the housing crisis on the disability community.

**SB410:** (New Title) making appropriations to the department of health and human services to support community and transitional housing through community mental health centers.

**SB434:** Establishing the extended stay housing program and exempting participating businesses from the tax on meals and rooms.

**SB454:** Increasing the annual real estate transfer tax revenue contribution to the affordable housing fund.

**SB518:** Relative to incentivizing landlords to accept housing choice vouchers.

- SB411:** Relative to emergency mental health services for persons 21 years of age and younger.
- HB1028:** Relative to the definition of mental illness for purposes of the New Hampshire mental health services system.
- HB1109:** (New Title) relative to requiring student identification cards to include the helpline for the National Alliance for Eating Disorders and the 988 Suicide and Crisis Lifeline.
- HB1609:** Relative to the commission on the primary care workforce and the state office of rural health.
- HB1079:** Relative to critical incident stress management team members.
- HB353:** Establishing an interstate compact for universal healthcare.
- HR23:** Calling upon the New Hampshire congressional delegation to support a national, universal health insurance program.
- SB128:** Relative to payment for legal services for persons involuntarily admitted for mental health services.
- SB235:** Relative to services provided through a primary care behavioral health model.
- SB457:** Relative to inpatient psychiatric services authorization and utilization review.
- HB1502-FN:** Relative to alcohol-related offenses and prohibitions (also related to transportation).
- HB1633-FN-A:** Relative to the legalization and regulation of cannabis and making appropriations therefor.
- HB1693-FN:** Relative to the use of psychedelics for therapeutic purposes.
- HB505-FN:** Relative to comprehensive mental health education in schools.
- HB544-FN:** Legalizing cannabis for retail sale.

## Transportation

- HB1520-FN-A:** Establishing a family assistance car ownership pilot program in the department of health and human services.
- HB1568-FN:** Relative to Medicaid reimbursement for non-transport emergency medical services calls.
- HB2024:** Relative to the state 10-year transportation improvement plan.
- HR29:** Declaring an economic justice bill of rights.
- SB409-FN:** Relative to reimbursement for ambulance services under the state Medicaid plan.
- HB1467-FN:** Relative to child passenger protection.
- HB651:** Authorizing the department of education and local school districts to contract with transportation network companies to provide school transportation services.
- HB1118:** Relative to the issuance of drivers' licenses for aliens temporarily residing in New Hampshire.
- HB1127:** Relative to the revocation and suspension of drivers' licenses.
- HB1467-FN:** Relative to requests for easements for the purpose of laying sidewalk along class I-IV highways.
