Room Temp Stability and Expiration	<b>Diluted</b> vaccine can be kept between 2°C to 25°C (35°F to 77°F) and administer within 6 hours.	8°C to 25°C (46°F to 77°F) for cumulative time of 24 hours for <u>unpunctured</u> vials.	9°C to 25°C (47°F to 77°F) for up to 12 hours for <u>unpunctured</u> vials.
	<b>Undiluted</b> vials may be stored at room temperature 8°C to 25°C (46°F to 77°F) for 2 hours.		
Punctured Vials = Storage after first dose is withdrawn	Any mixed vaccine that has not been administered within 6 hours should be wasted.	2°C to 25°C (35°F to 77°F) for 12 hours.	Refrigerated at 2°C to 8°C (35°F to 46°F) for 6 hours <b>OR</b> room temperature 9°C to 25°C (47°F to 77°F) for up to 2 hours. These <b>times may not be added together</b> , if punctured vials reach room temperature (>8°C) it must be discarded after 2 hours even if it was moved to a refrigerator.
<b>Make sure all wastage and remaining doses in open multi-dose vials that have expired are documented through an inventory adjustment in the NHIIS! You must create and submit a Vaccine Return for all unopened expired COVID19 vaccine, enter "0" shipping labels, and dispose of per your medical waste procedures.</b>
